### **SEVENTH BARGAINING MEETING**



#### **What Union Members have just WON this round:**

- Pandemic Provisions Clause
- Early out from 4 hours prior to the start of your shift
- Personal Protective Equipment (PPE) clause
- ARBITRATION – This is BIG. Your union can now enforce this agreement.



#### **COMPANY REFUSING TO PAY OUT. What members are fighting for:**

Your union has been fighting for additional allowances to have your work recognised & respected, and the company responded **NO** to the following:

- Public Area Allowance
- Hazard/Danger Allowance
- RDO Call in Allowance
- External Properties Allowance
- First Aid Allowance for Security – your union proposed 6.5%, the company only thinks your worth 2%.

#### **NEXT STEPS: Whose side are you on?**

The next bargaining meeting will be held on the 28th July.

**Classifications will be discussed at Bargaining Meeting 8. What level you're on and what it means for the next several years, will be determined over the next few meetings. Do you want a living wage or just want to get by?**

**Union Delegates and Members need your help.** The stakes couldn't be higher. Union delegates are tirelessly working in their own time to improve your pay and conditions.

**Non-Members.** Union members are contributing for your wages and conditions to be better going into Queens Wharf.
